In order to secure additional nominations on the ballot, a member will need to present a petition for nomination addressed to the Secretary of the Board of Directors, to a member of management of Solidarity Community Federal Credit Union, no later than 3 pm on February 12th, 2021, at 201 Southway Boulevard East, Kokomo, Indiana. This petition must be signed by 1% of the membership (primary members), which is equal to 265 primary members. For identification purposes, the members signing the petition must do so legibly by printed name, signature, and the last four digits of their social security number. A signed statement must accompany each petition from the nominee certifying his/her willingness to serve if elected. The nominee will also furnish biographical data, a photograph, and his/her qualifications for the office for which he/she has been nominated. This information will be used for publication in connection with the mail ballot process. The election shall be determined by a plurality vote. The election of officials will be conducted by mail ballot when more than one nominee per office vacancy exists. All members 16 years of age and older will be eligible to vote. The election will not be conducted by mail ballot, and there will be no nominations from the floor when there is one nominee per vacancy. If there are no nominations by petition, the nominees who were nominated by the Nominating Committee will be declared elected by the Chairman of the Board of Directors at the Annual Meeting. The voting process will allow all eligible members an equal opportunity to vote for the nominee of their choice without attending the Annual Business Meeting. It is the opinion of the Board of Directors that this is the most democratic manner in which to handle this election.
