

E-Statement and Other Disclosures Received by Electronic Delivery

By signing this document, you consent to receive via electronic delivery all required statements and disclosures, regarding all deposit accounts, loans and other services you have with Solidarity Community FCU. Disclosures that may be delivered to you electronically may include, but are not limited to:

- Regularly scheduled account statements.
- Annual Privacy Policy.
- Annual Electronic Funds Transfer Notice.
- Change-in-terms information for your account.
- Notices of activity on your account.
- Other disclosures we may be required to provide.

This agreement shall remain in effect for the life of the account unless:

You notify the credit union in writing, allowing up to 10 business days from receipt of the notification for the service to be terminated, at the address under the "Contact Methods" heading at the bottom of this page. You are notified by the credit union via e-mail or U.S. Mail that you will no longer be enrolled in the service.

You may withdraw consent for electronic delivery of disclosures at any time, but doing so will not affect the legal effectiveness, validity or enforceability of electronic disclosures that were made available to you prior to the implementation of your withdrawal. There are certain types of accounts (ie. checking accounts) that may require electronic statements. Withdraw of consent for electronic delivery may result in an additional fee for the receipt of printed media and/or Solidarity FCU may change your current account to one that does not require electronic delivery. Please check your account agreement or you may contact Solidarity for more information on how electing to receive printed media may affect your accounts. To withdraw consent and request that future documents be provided via printed media, delivered via U.S. Mail or other appropriate carrier, you must write to Solidarity Community FCU at the address listed below.

In the event the electronic mail address (e-mail address) for you is no longer valid, it is your responsibility to notify the credit union using one of the following methods listed at the bottom of this page under the "Contact Methods" heading. If Solidarity Community FCU receives notification that electronic delivery is not possible due to an incorrect or closed email address, we may elect, at our discretion, to choose to revert your account(s) to standard delivery via U.S. Mail without additional notification.

In order to receive electronic delivery of disclosures you must have access to the following:

- A valid e-mail account capable of receiving .PDF attachments.
- A computer with an internet connection.
- Adobe® Acrobat Reader® (version 4.0 or higher)
 - The most recent version may be downloaded free of charge from <http://www.adobe.com>
- An e-mail program capable of receiving .PDF attachments **or**
- A web based email account accessible using:
 - Microsoft® Internet Explorer® (version 5.0 or higher) or
 - Mozilla Firefox® (version 1.5 or higher)

Solidarity Community FCU will deem a disclosure received after 1 business day if no notification of a failed delivery is received by our system. You may request a paper copy of statements and disclosures provided electronically by contacting us in one of the following methods listed at the bottom of this page under the "Contact Methods" heading.

By enrolling, you acknowledge that it is your responsibility to review these disclosures in a timely manner. You further acknowledge that you are responsible for retention of these disclosures for your records.

A fee may apply for additional printed or electronic copies of statements requested after the statement delivery. No fee shall apply for providing other disclosures as required by law. Additional electronic copies of disclosures may be delivered to other e-mail addresses once the initial enrollment has been completed. For information about adding additional e-mail delivery addresses, please contact the credit union.
